**SUBJ.: 2010 Resident Managers and Superintendents Agreement with Local 32B-32J, SEIU**

In accordance with the renewal of the 2010 Resident Managers and Superintendents Agreement, said agreement provides for wage increases on the following schedule:

## Resident Managers and Superintendents:

- 1) Effective June 21, 2010 - \$18.00 per week (\$.45 per hour).
- 2) Effective June 21, 2011 - \$18.00 per week (\$.45 per hour).
- 3) Effective June 21, 2012 - \$25.00 per week (\$.625 per hour).
- 4) Effective June 21, 2013 - \$26.00 per week (\$.65 per hour).

Benefit Fund contributions under this Agreement are in the same amount as provided for in the 2010 Apartment Building Agreement.
