SUBJ.: 2006 Apartment Building Agreement Increases with Local 32BJ, SEIU

WAGES:

The 2006 Apartment Building Agreement provides for Wage Increases effective April 21, 2009 as follows:

- 1) **Others:** \$.2625 per hour or \$10.50 per forty hour week.
- 2) **Handypersons:** \$.2875 per hour or \$11.50 per forty hour week.
- 3) **Working Superintendents:** \$.2875 per hour or \$11.50 per forty hour week.

Superintendents covered under the separate Resident Managers and Superintendents Agreement receive an increase of \$11.50 per week (\$.2875 per hour) effective June 21, 2009.
